Time of Use – Plug-in Electric Vehicle Rate (Rate Code 6)

AVAILABILITY

This Time of Use – Plug-in Electric Vehicle Rate is an experimental rate available to residential members with a **separately metered** Electric Vehicle Supply Equipment (EVSE) capable of providing Level 1 or Level 2 charging for plug-in electric motor vehicles.

This rate is a voluntary rate and only available to the first 100 members to request service.

“EVSE” means a device or apparatus, including vehicle supply cable, connector, internal relays and controls designed specifically for the purpose of delivering energy from the premise’s wiring to a plug-in electric motor vehicle. This equipment must meet or exceed all applicable codes and standards.

“Level 1” charging means providing 120 volt through a standard household receptacle.

“Level 2” charging means providing 208-240 volt single phase alternating current energy to an onboard charger of an electric motor vehicle with a maximum current specified at maximum 32 continuous amps and a branch circuit breaker rated at 40 amps.

Participating members agree to:

1. Supply the Cooperative with suitable locations for installation of metering and other necessary equipment.
2. Provide sufficient access to their premises to install and maintain metering and other necessary equipment.
3. Be responsible for and indemnify and hold the Cooperative harmless with respect to the adequacy, condition and operation of electrical wiring and electrical system on member’s premises and ensure that such wiring and system meet, at minimum, the provisions of the NEC, the governmental authorities having jurisdiction and the requirements of the Cooperative.
4. Take responsibility for and indemnify and hold the Cooperative harmless with respect to the adequacy, condition and operation of the member-owned EVSE charging equipment.
5. Sign an agreement with the Cooperative demonstrating their understanding of the above requirements.

TYPE OF SERVICE

The service is alternating current, 60 hertz, single phase, 120 or 240 nominal volts, Level 1 or Level 2 charging as defined.

RATE

Service availability charge	@	\$0.21 per day
On-Peak KWH	@	16.0 ¢ per kWh
Off-Peak KWH	@	4.50 ¢ per kWh

Off-Peak hours are defined as 10 PM to 6 AM every day. On-Peak hours are defined as all hours not defined as Off-Peak.

WHOLESALE POWER COST ADJUSTMENT CHARGE

The Cooperative's Wholesale Power Cost Adjustment Charge will apply to all kilowatt-hours sold under this Schedule.

TERMS OF PAYMENT

The above are net rates and apply in cases where the bill for service furnished under this Schedule is received at the office of the Cooperative on or before the scheduled due date, which is no less than 15 days after the bill date. Payments not received on or before the due date are deemed delinquent and are subject to penalties. If not so paid, the gross rates, which are the rates above, plus one and one-half (1 ½) percent, then applies.

CONTRACT PERIOD

The original term of this contract shall be one year and thereafter until terminated by either party on ninety (90) days written notice. The Cooperative may require a contract for a longer original term of years when justified by the circumstances.

TAXES

To the above charges will be added any applicable state, federal or local government sales tax including franchise fees.
